

## Terms and Conditions – Anime Competition

1. By entering the competition, each entrant will be deemed to have accepted these terms and conditions and to have agreed to be bound by them.
2. Entrants must follow the competition instructions to enter the competition. Failure to follow the instructions and to supply all requested information by 5.00pm on Sunday 31 October 2021 will result in the entry being invalid.

4. Only one entry will be accepted, submitted by either an individual young person or by a group of young people. (Note a young person cannot be part of more than one entry submission. There is a limit of five young people in a group entry). Please note that only one voice spot is available in the Anime production so the group will be required to nominate one member for this purpose.
5. By entering the competition, the winner/s agree/s to their name, city/town of residence, and competition entry being published on @ministryyouthdevelopment. Accepting the prize constitutes a winner's consent to be photographed and/or interviewed by the Ministry of Youth Development – Te Manatū Whakahiato Taiohi for publicity purposes. This includes reposting their content on the Ministry of Youth Development and/or Ministry of Social Development's social media platforms and other publications.
